Subject: **GRANT OF ADHOC RELIEF ALLOWANCE – 2014 @ 10% OF BASIC PAY TO ALL THE EMPLOYEES OF PROVINCIAL GOVERNMENT AND 20% INCREASE IN MEDICAL ALLOWANCE TO THE EMPLOYEES FROM BPS-1 TO 15.**

Dear Sir,

The competent authority is pleased to sanction 10% Adhoc Relief Allowance - 2014 on running basic pay of all the regular employees of Provincial Government w.e.f 1st July, 2014.

2. The amount of this Adhoc Relief Allowance - 2014:-
 - i will be subject to Income Tax
 - ii will be admissible during leave, and entire period of LPR except extra-ordinary leave
 - iii will not be treated as part of emoluments for the purpose of calculation of pension commutation / gratuity and recovery of House Rent
 - iv will not be admissible to the employees during the tenure of their posting / deputation abroad
 - v will be admissible to the employees on their repatriation from posting/deputation abroad at the rate and amount which would have been admissible to them, had they not been posted abroad.

3. The term “Basic Pay” for the purpose of Adhoc Relief Allowance – 2014 will also include the amount of personal pay granted on account of annual increment(s) beyond the maximum of the existing pay scales.

4. The competent authority has further been pleased to sanction **20% increase** in the **Medical Allowance** to the regular employees of Provincial Government from BPS-1 to BPS-15 in the following manner:-

BPS	Existing Rate	Revised Rate
1 to 15	Rs.1,000/-	Rs.1,200/-

5. The above **Adhoc Relief Allowance – 2014 & Medical Allowance** shall be accommodated / met out within the budgetary allocation for the year 2014-15 by the respective departments and no supplementary grants would be given on this account.


