No.SOR-III(S&SAD)2-54/2010. In exercise of the powers conferred under section 23 of the Punjab Civil Servants App 1974 (VIII of 1974), Governor of the Punjab is pleased to direct that in the rules made or deemed shave been made under the Act, the following amendments shall be made:

AMENDMENTS

In all the rules made peemed to have been made under the Act:

- (1) against the post of Superintendent, wherever occurs, for the expression "BS-16" the expression "BS-16" the

 - (iii) proficient in Microsoft Office or any other compatible office application and he shall demonstrate such proficiency."
